## **House Ways and Means Budget**

At the end of April, the Massachusetts House of Representatives passed its FY 2020 budget totaling \$42.7 billion. This budget constitutes a 3% increase over the FY19 budget and closely resembles Governor Baker's Fiscal Year 2020 House I Budget Recommendations. The House budget includes the following highlights:

- The Department of Mental Health is funded at approximately \$890 million. The Adult Community Services line item (5046-0000) is funded \$489.3 million, a level that is consistent with current FY19 funding levels. The House budget included an additional \$500,000 over House I recommendations. The Children and Adolescent Services line item (5042-5000) is funded at \$93.4 million. This is a \$2.8 million increase over the administration's recommendation, and restores the account to projected final FY19 spending levels.
- The Bureau of Substance Addiction Services is funded at \$153,281,348. This level of funding represents a decrease of nearly \$2.7 million from projected final FY19 spending.
- MassHealth is funded at \$16.57 billion, a \$343 million increase over the Administration's House I recommendation. MassHealth covers 1.9 million residents and accounts for approximately 38% of the House's total proposed budget.
- Consistent with Administration's recommendations, the Chapter 257 Rate Reserve is funded at \$20.5 million for FY20.
- The House budget retained a House I proposal (1599-0105) for costs associated with the delivery of medication assisted treatment in County Correctional facilities, and funds this new account at \$10 million in FY20.
- The House budget elected to forego several of the Governor's tax proposals, including a tax on opioid manufacturers, and a tax on e-cigarettes and vapor products.

# ABH Announces Vice President for Mental Health Lydia D. Conley Elevated to President and CEO

ABH has announced that ABH's vice president for mental health, Lydia D. Conley, will assume the role of President and CEO, succeeding Vic DiGravio, as of July 1, 2019.

For two decades, Conley has worked in the government and non-profit sectors, helping to shape public policy that has established Massachusetts as perhaps the nation's most progressive provider of behavioral health services and insurance coverage for mental health and addiction treatment.

"The board unanimously agreed that Lydia was the ideal choice to lead ABH in the coming years," said Diane Gould, chair of ABH's board of directors and president and CEO of Advocates, Inc. "Lydia is one of the most highly respected and knowledgeable advocates in the nation for organizations serving individuals with behavioral health needs. We are thrilled that she has accepted the challenge of leading ABH."

In her role as vice president, Conley has worked closely with state and federal officials to advocate for equitable reimbursement to support the ability of ABH member organizations to continue to deliver high quality services to individuals living with mental health and/or substance use disorders.

I am excited to assume this new role with ABH and continue working with community-based behavioral health providers and the Commonwealth to improve the lives of men, women and children living with mental health and addiction disorders," Conley said. "We have made a great deal of progress, but every year, every month, and every day we learn new lessons about how to better provide essential services, and when and where people need them."

## **Paid Family and Medical Leave Act**

Under the new Paid Family and Medical Leave Act, employers must provide employees and independent contractors with notices informing them of their rights under the law. Notices must be provided to employees within 30 days of their start date or by May 31, 2019, whichever is later. Independent contractors must be given notices at the start of their contracts or by May 31, 2019, whichever is later. These notices will explain that employees may be eligible for up to 20 weeks of paid medical leave, up to 12 weeks of paid family leave, and up to 26 weeks of paid military caregiver leave. Paid leave will be funded by employer contributions and will be administered by the Department of Family and Medical Leave.

## **Expanded Access to MAT**

The SUPPPORT for Patients and Communities Act, which makes amendments to the Controlled Substance Act and provides for greater flexibility relative to the provision of medication assisted treatment (MAT).

Under the SUPPORT Act qualified physicians can treat up to 100 patients in the first year of MAT practice with a waiver. Current practitioners with a waiver from SAM-HSA to treat 30 patients at one time may submit notification to SAMHSA requesting an increase in patient limits. SAMHSA may then increase patient limits of current practitioners to 100 patients. or more information, click <u>here</u>.

## **Shatterproof Roundtables**

Shatterproof has been working with the National Quality Forum (NQF) to gather multi-stakeholder guidance to inform implementation of a Rating System for Addiction Treatment Programs. ABH and the Recovery Homes Collaborative are working with Shatterproof to schedule two in-person SUD provider roundtable meetings on May 21 and 22. These meetings are a follow-up to the April webinars.

The May 2019 provider roundtables will focus on the Rating System Treatment Program Survey measures of the pilot program. The event will be run as a moderated discussion to feasibility test the measures recommended for inclusion in the Treatment Program Survey.
