- ❖ **Robert Dorwart, M.D., Award for Mental Health** (*Individuals Only*)
The recipient must be a member of ABH who has demonstrated a personal long-term commitment to the goals of ABH and who has provided leadership and support to the association, its members, and staff around mental health issues.
- ❖ **Moe Armstrong Award for Peer Leadership** (*Individuals Only*)
This award was established to honor Moe Armstrong for his courage and conviction in advocating for the critical role that peer leaders play in helping people recover from mental health and addiction disorders. The recipient of this award must have made an exceptional contribution to the development and/or strengthening of the role of consumers in the mental health and/or addiction treatment systems.
- ❖ **Elizabeth Funk Emerging Leader Award** (*Individuals Only*)
Nominees must be under the age of 40. The recipient must show evidence of commitment to behavioral health through his/her ability as an emerging leader within the field. The nominee should display the ability to motivate staff and communicate effectively in their role as a developing leader.
- ❖ **Provider Recognition Awards** (*Individuals or Groups*)
Nominees show evidence of personal commitment to quality and innovation in their work performance and carry out that commitment in a manner deserving of special recognition in any of the following categories:
 - **Excellence in Outcomes:** Integration, utilization and management of client outcomes for quality improvement
 - **Excellence in Best Practices:** Planning, implementation and on-going integration of best practices
 - **Excellence in Program Leadership:** Program director/staff who exemplify outstanding leadership qualities

- **Excellence in Administration and Finance:** Exceptional management of program/agency/corporate finances and/or operations
