# **Governor Releases FY 18 Budget**

Governor Charlie Baker proposed his Fiscal Year 2018 Budget on January 25 (referred to as House I). The \$40.5 billion budget for fiscal year 2018 includes an increase in state spending of \$1.655 billion. This represents a 4.3 percent growth in spending over projected spending in the current fiscal year. The budget relies on \$27 billion in tax collections. Governor Baker proposes to move \$98 million into the Stabilization Fund and uses less than \$100 million in one-time revenues. A full summary is available here.

The FY18 budget includes the following highlights:

- The Department of Mental Health is funded at \$773,074,057. This is a \$5.4 • million increase over projected FY18 spending.
- The Bureau of Substance Abuse Services (BSAS) is funded at \$140.6 million.
- Governor Baker projects a \$997 million increase for MassHealth, \$600 million • of which is tied to increased enrollment. MassHealth projects there will be over 2 million MassHealth members by June 2018.
- Governor Baker proposes rate caps on hospitals and other providers as a cost-control mechanism.
- Behavioral health and primary care providers are exempt from the rate caps.
- The Governor's budget includes \$50.8 million in funding for Chapter 257 rates.

### ABH and MA League of Community Health Centers Event Office of Community Corrections: Innovation, Motivation for Community Safety

ABH and the Massachusetts League of Community Health Centers invite you to attend a special presentation by the Massachusetts Probation Services, Office of Community Corrections (OCC) on February 9th.

OCC is charged by statute with the development of community corrections programs to be implemented as intermediate sanctions for probationers, parolees and ex-offenders returning to the community post incarceration. The OCC executes this charge through two major initiatives: Community Service Programs (CSPs) and Community Corrections Centers (CCCs).

The presentation will focus on CCCs and why enhanced supervision is vital to safer and stronger communities; how CCCs are increasingly trying to leverage and access more community-based behavioral health services as a component of sentencing; and what enhanced supervision at the CCC is all about for service providers, probation, and parole officers and participants.

# Monthly digest of disciplinary reports

As you may know, the Division of Professional Licensure (DPL) updated their website a few months ago and stopped producing a Monthly Digest of Disciplinary Actions. As many ABH members used this report to monitor their professionally licensed providers and meet accreditation requirements, ABH reached out to DPL about this important issue.

### **Support ABH's Priority Legislation**

As the Legislature begins it's new legislative session, please take a moment to ask your Senator and Representative to co-sponsor ABH's priority legislation. Click <u>here</u> to send an email (it's easy, we promise).

**1.) Senate Docket 212/House Docket 2309**: Limiting retroactive denials of health insurance claims for mental health and substance abuse services. Lead Sponsors: Representative Jim O'Day and Senator Mike Rodrigues

This bill would limit both MassHealth and commercial health insurers to a six-month period for recovering payments to a behavioral health provider for behavioral health services. When providers deliver a service in good faith and in compliance with eligibility rules, they should be compensated without fear of insurance companies taking back these reimbursements years or months after the services were provided. It would also require that MassHealth institute a back-end process to reconcile payment between payers without involving the provider.

2.) Senate Docket 1921: Providing access to full spectrum addiction treatment services. Lead Sponsor: Senator John Keenan

This bill would require commercial insurance to cover up to 30 days of treatment, improving access to step-down treatment at an estimated cost of only 5 cents per insured member per month.

In 2014 the Legislature established that commercial insurance companies must provide for at least 14 days of addiction treatment, and asserted that decisions about medical necessity must rest solely with the patient and their clinician for this 14-day period. The 30-day commercial insurance requirement proposed in this bill would mirror the coverage already being provided by MassHealth, which was recently expanded through the Baker administration's 1115 waiver.

The deadline for legislators to cosponsor bills in the House is **Friday**, **February 3rd**. The deadline to cosponsor Senate bills is later in the process but we strongly encourage you to contact your Senators today. House and Senate members can sign on as cosponsors to bills filed in each chamber.

Massachusetts has received approval from the Centers of Medicare and Medicaid Services (CMS) to extend the MassHealth Electronic Health Record Incentive Program attestation deadlines for Program Year 2016 for both Eligible Hospitals and Eligible Professionals to May 31, 2017.
