Shatterproof

Founded in 2012, Shatterproof is a national nonprofit dedicated to ending the devastation that addiction causes families. Shatterproof's work is focused on advocacy, supporting families and ending the stigma that surrounds this disease. Among its accomplishments as an organization, Shatterproof launched the Substance Use Disorder Treatment Task Force in 2017. The Task Force released The Shatterproof National Principles of Care©, 8 essential criteria for treatment. Last fall, sixteen payers, representing 248 million lives, signed on to support these principles, agreeing to identify, promote, and reward one core set of evidence-based principles for addiction treatment.

In 2017, Shatterproof launched the Rise Up Against Addiction 5K Walk/Run event series in 5 cities across the country. In Boston, 1,400 people came together to support Shatterproof's mission. This year, the event expands to 11 cities nationally, including returning to Boston on September 23. Local treatment and residential service providers can form teams or join the Community Partner program, highlighting the services they offer locally. Draft PDT Rate and Program Regulations

MassHealth has published public comment/public hearing information for proposed changes to the PDT manual and rate regulation. ABH has requested the rate methodology for the proposed rate. Public hearings on both the rate and on the program manual will be held on Monday, July 9th at 10 am (program manual) and 11 am (rate) in Quincy. ABH will be developing testimony on both.

Budget Conference Committee

ABH recently submitted its budget request to the conference committee (the committee charged with working out the differences between the House and Senate budgets). Specifically, ABH asked that the conference committee:

- Include the Senate directive of \$4 million for the outpatient mental health and addiction treatment system at MassHealth (line item 4000-0700).
- Support the House appropriation of \$5 million for the jail diversion program line item 4512-0202.
- Support the Senate appropriation of \$6,548,125 for the DHCD Rental Subsidies for DHM clients' line item (7004-9033).
- Remove all earmarks that were included for individual organizations in the FY 2018 budget.

Note that these were not ABH's only budget priorities. Funding levels or budgetary language that is the same in both the House and Senate budget will automatically be included in the final conference committee budget.

Behavioral Health Recruitment Program!

The <u>Community Mental Health Center Behavioral Health Recruitment Fund</u> is a multiyear, \$800,000 program funded by EOHHS as part of MassHealth's \$1.8 billion Delivery System Reform Incentive Payment (DSRIP) program. This prescriber recruitment program is being administered by the Massachusetts League of Community Health Centers with support and guidance from ABH.

The goal of the program is to increase the number of psychiatrists and nurse practitioners at community mental health centers across the state. The program offers loan repayment and professional development initiatives.

The program will include approximately 15 psychiatric recruitment packages and seven nurse practitioner recruitment packages over a three year period. The psychiatrist recruitment package is a two-year package totaling \$150,000 per psychiatrist (\$50,000 for loan repayment and \$50,000 per year for two years "to lead special projects related to accountable care"). The nurse practitioner recruitment package is a two-year package totaling \$110,00 per nurse practitioner (\$30,000 for loan repayment and up to \$40,000 per year for two years "to lead special projects related to accountable care"). Up to \$40,000 will be available for each project.
