FY 19 House Budget

The Massachusetts House of Representatives passed its version of the Fiscal Year 2019 budget on Thursday, April 26. During budget debate, the House added \$81.3 million to the House Ways and Means budget proposal. The administration, the House and the Senate had previously agreed on a consensus revenue forecast of \$27.594 billion, which represents a 3.5% growth in state tax revenue over adjusted FY18 projected revenue of \$26.661 billion. The House Budget, which totals \$41 billion, proposes spending approximately \$164.6 million more than the Governor's Budget proposal, and counts on \$63 million in new revenue from marijuana sales.

The FY19 budget includes the following highlights:

- The House budget for DMH fully funds the historic increase in community funding requested by Governor Baker, including almost \$95 million in increases in the adult community services line item.
- The House budget also increases funding for DPH/BSAS beyond levels recommended by the Governor including expanded funding for jail diversion programming, the Massachusetts Access to Recovery Program (MA-ATR) and funding for five new recovery centers.
- An increase of \$13.4 million for DCF over the current fiscal year.
- Approximately \$38 million in funding in the Chapter 257 rate reserve for rates adjusted in the upcoming year.
- The House budget did not recommend adopting the Governor's proposal to move 140,000 individuals from MassHealth to the Connector.

Next, the Senate Committee on Ways and Means will propose its budget. Once the Senate passes a FY 19 budget, the House and Senate will appoint a conference committee to work out the differences between the two bills.



Addiction Treatment Data

ABH recently created an updated fact sheet regarding addiction treatment data. This new fact sheet shows FY 14 to FY 17 enrollment and bed capacity totals in ATS, CSS, TSS and Recovery Home programs across the state. Enrollment in programs beyond ATS continues to grow, while



the number of individuals cycling through detox has decreased over time.

BSAS Short-Term Enhancement RFR

DPH/BSAS is seeking proposals for short-term enhancement projects for existing operational non-funded BSAS Substance Abuse Recovery Support Centers. The 10 currently BSAS-funded recovery support centers are not eligible for this RFR.

The RFR for this procurement is available here. Eligible centers will offer individuals recovery education and peer support that helps prevent relapse and promote sustained recovery from alcohol and other drug use. Proposals are sought from all 6 BSAS regions in the state of Massachusetts. It is expected that eligible respondents will have in place the demonstrated experience, expertise, and infrastructure to perform the work outlined in this request, including prior experience providing culturally appropriate recovery support for individuals who use substances, especially peer-to-peer recovery services. This procurement is for \$250,000 for three to five awards and is one-time funding that ends on June 30, 2018. Providers that want to sustain the services beyond June 30, 2018, should demonstrate how their proposed project will be able to continue after this end date.

All monies must be spent by June 30, 2018.
