Keeping Coverage

MassHealth ACOs are integrated networks of physicians, hospitals, and other community-based healthcare providers that are accountable for the quality, cost, and member experience of care for 1.2 million MassHealth members.



MassHealth selected 17 healthcare organizations to participate in the re-procured MassHealth ACO program. The new health plans will launch on April 1, 2023.

In February, members were mailed notices providing MassHealth health plan enrollment updates. Members generally follow their Primary Care Providers (PCP) with the PCP's ACO. If a member's PCP assignment is not available in MassHealth systems, the member will move with their ACO partner.

MassHealth Choices, MassHealth has a member-facing website called MassHealth Choices to assist members and applicants choose a health plan. The site has been updated with the new plan options.

MassHealth Enrollment Guide, The MassHealth Enrollment Guide, also accessible through MassHealth Choices website, is an excellent resource for members and providers alike. It includes information on plans, services areas and behavioral health benefit access.

Introducing our Keynote: We are very excited to announce EOHHS Secretary Kate Walsh as this year's Annual Meeting speaker! As Secretary of Health and Human Services, Kate Walsh leads the Executive Office of Health and Human Services (EOHHS), which provides access to medical and behavioral health care, long-term services and supports, and key nutritional and financial benefits. She represents a team of more than 21,000 staff across 11 agencies and the MassHealth system, who work daily to provide services and programs for nearly 1 in every 3 Massachusetts residents.



Prior to her appointment to Governor Healey's cabinet, Secretary Walsh served as CEO of the Boston Medical Center (BMC) health system for 13 years, overseeing an annual operating revenue of \$6 billion. The BMC health system is comprised of a 514 bed, academic medical center that is the primary teaching affiliate of Boston University Chobanian & Avedisian School of Medicine, as well as WellSense Health Plan, a Medicaid Managed Care Organization, and Boston HealthNet, a network affiliation of 14 community health centers.

Secretary Walsh received her Bachelor of Arts and Master of Public Health degrees from Yale University. She has served as a member of the Board of the Federal Reserve Bank of Boston, the Boston Public Health Commission, the Massachusetts Hospital Association, the Association of American Medical Colleges, Pine Street Inn, and Yale University.

List of Contracted BHCA Providers

The Division of Insurance (DOI) and Department of Mental Health previously issued Bulletin 2018-07 to clarify that insured health plans must include specific benefits for Behavioral Health for Children and Adolescents (BHCA). These benefits include: Intensive Care Coordination; Family Support and Training; In-home Behavioral Services; Inhome Therapy; Therapeutic Mentoring; Community-based Acute Treatment for Children and Adolescents (CBAT); and Intensive Community-based Acute Treatment for Children and Adolescents (ICBAT).

Accommodations and Language Updates in POSC

MassHealth has upgraded the online provider directories to include information about accessibility and language accommodations available at a provider's service location. Many individuals with disabilities experience barriers to health care and MassHealth is working towards providing the residents of the Commonwealth with easy to access information that will allow them to make informed decisions on where they may receive their care. The MassHealth Business Support Services (BSS) Provider Relations team will be hosting information and training sessions to show you how to update both accessibility and language accommodations using the provider file update functions in POSC.
