## FY 2022 Senate Budget

On May 27, the Senate passed their version of the Fiscal Year 2022 Budget (S.2465), totaling $\$ 47.7 B$. The Senate engrossed their final budget recommendations after debating the Senate Committee on Ways and Means (SWM) initial recommendations (S.3) on May 25. The Senate budget closely mirrors S.3. S. 2465 relies on a consensus revenue number for FY22 of $\$ 30.12 \mathrm{~B}$, a $3.5 \%$ growth over the revised FY2I projections. The budget utilizes $\$ 1.55 \mathrm{~B}$ from the Stabilization Fund (aka 'The Rainy Day Fund'). The budget will now go to a Conference Committee, where differences between the House and Senate budgets will be reconciled by a committee of three Senators and three Representatives.

ABH has provided a full analysis of the FY22 Senate Ways and Means budget with more details, and will be releasing another analysis after the Conference Committee reports out the final FY22 budget recommendations.

The FY22 Senate proposed budget includes the following highlights:

- The Department of Mental Health (DMH) is funded at $\$ 948$. The Adult Community Services line item (5046-0000) is funded at $\$ 507.8 \mathrm{M}$, an increase of $\$ 2.8 \mathrm{M}$ over the Governor's $(\mathrm{HI})$ recommendations. .
- The Bureau of Substance Addiction Services (BSAS) is funded at \$190M. This represents an increase of $\$ 35 \mathrm{M}$ over HI and includes several ABH and Massachusetts Coalition on Addiction Services (MCAS) recommendations.
- NEW language in the SWM budget was retained that appropriates $\$ 6.2 \mathrm{M}$ for BSAS to restore programmatic services reduced due to the COVID emergency. ABH is working to determine the intent of this language. .
- The Senate maintained SWM language adding in a NEW line item, 4000-0053, funded at $\$ 10$ million, to establish a grant program for a program of assertive community treatment (PACT) for individuals under the age of 22 . This is an ABH recommendation.
- The Chapter 257 rate reserve (1599-6903) is fully funded at $\$ 79 \mathrm{M}$, consistent with the Administration's recommendations. The inside reporting language differs from that of the House language and ABH will be working with our partners in The Collaborative on next steps.

- The Senate retained a HI proposal (1599-0105) for a $\$ 15 \mathrm{M}$ reserve fund for costs associated with delivering MAT in county correctional facilities.
- S. 2465 also included a proposal to require the Children's Behavioral Health Advisory Council, of which ABH is already a member, to conduct an evaluation of the existing and anticipated impacts of the COVID-I9 pandemic on children's behavioral health and the provision of services and supports, funded at $\$ 150,000$.
- The Senate budget recapitalizes the Behavioral Health Outreach, Access \& Support line item (45I3-2020) with $\$ 10 \mathrm{M}$, and directs funds to:
- $\$ 3.5 \mathrm{M}$ for a pilot program to increase student access to tele behavioral health services in schools;
- \$500,000 for a mental health workforce pipeline program;
- \$IM for a public awareness campaign to promote the awareness and use of available BH services; and
- $\$ 5 \mathrm{M}$ for a loan forgiveness program for mental health professionals. $\$ 3 \mathrm{M}$ of these funds must be focused on the recruitment and retention of child and adolescent psychiatrists in community mental health and community health centers. Individuals chosen for the forgiveness program are eligible for up to $\$ 300,000$ per individual, must commit to 5 years in a community mental health or health setting and see a caseload of at least 25 percent of patients enrolled in Medicaid. This is an ABH priority.


## DSRIP Student Loan Repayment

The Massachusetts League of Community Health Centers (the MassLeague), on behalf of the MassHealth Delivery System Reform Incentive Payment (DSRIP) Statewide Investments (SWIs) Program, has released a Request for Proposals for the fourth cycles of the Student Loan Repayment Program and the Primary Care/Behavioral Health Special Projects Program.

The Student Loan Repayment Program aims to increase the number of providers practicing in community health centers and community-based behavioral health provider organizations by offering up to $\$ 50,000$ in student loan repayment for primary care and behavioral health providers who commit to four years of practice in an eligible community-based setting. Please note that this will be the last opportunity to apply for student loan repayment under the MassHealth DSRIP Statewide Investments Program. This final application cycle includes 50 slots dedicated to Masters-prepared unlicensed behavioral health providers in community-based behavioral health provider organizations who intend to become licensed within the next year.

The Primary Care/Behavioral Health Special Projects Program aims to engage and retain primary care and behavioral health providers in community-based settings while also supporting innovative on-the-ground projects that advance the ability of community-based provider organizations to success in an accountable care environment. To that end, the program makes available up to $\$ 40,000$ to support provider-led projects in eligible organizations.

It is critical that behavioral health providers receive rates that truly reflect the value of behavioral health services, allow for the expansion of data analytics and population health strategies, enable flexibility to achieve person-centered treatment, and that resource providers to offer their staff stable, appropriate and family-sustaining salaries with the potential to grow their careers in the community-based system.

Governor Charlie Baker intends to end the State of Emergency June 15, 2021 for Massachusetts. Please be aware of the termination of the State of Emergency and its impact on your organization with respect to the following:

All Provider Bulletin 3|4: Updated MassHealth Telehealth Policy - extended "90 days beyond the final date of the Massachusetts Public Health Emergency"

DOI Bulletin 2021-04: Managed Care Practices and Continued Access to Telehealth Services - "until at least 90 days after the termination of the state of emergency"

MassHealth Community Partner Information: Updates Related to the Coronavirus Disease 2019 (COVID-I9) - "This guidance shall remain effective for the duration of the state of emergency"

ABH will continue to update our members with clarifications and guidance related to the lifting of restrictions and the termination of the State of Emergency as they are released.
